### **ODE CEREMONY SPEAKER: DUANE BOULIGNY**

This year's guest speaker at the Omicron Delta Epsilon ceremony is Duane Bouligny (Econ '94). Duane is a Managing Director in the Leveraged Finance group at Wells Fargo Securities and is based in San Francisco. He manages the specialized industries debt capital markets team, which structures and originates loan syndications and high yield financings, primarily for the gaming industry. During his tenure at Wells Fargo Securities he has also managed teams covering the energy, forest products, and the beverage industry.

Prior to joining Wells Fargo in 1998, he was an Assistant Vice President at Sumitomo Bank in San Francisco. After completing a commercial banking training program, a relationship manager at NationsBank in Florida.

Duane served on the Providence College (PC) Board of Trustees from 2011 -2020 as a member of the Academic Affairs, Building and Property, and Student Affairs committees. Upon his retirement in June 2020, he was named trustee *emeritus* by the board.

A generous benefactor to the College, he established the Duane '94 and Nancy Bouligny Scholarship Fund in 2011 with his wife to assist African-American and Asian-American students. A graduate of Providence College, where he studied eco-

nomics, he went on to receive an Honorary Doctorate in 2021 and rejoined the board in 2022.

Duane currently lives in Greenbrae, California with his wife and three children, Julia, (15), Cade, (13), and Corrina, (11) where they enjoy spending time in the mountains at their home in Lake Tahoe.

### **OMICRON DELTA EPSILON HONOR SOCIETY**

Omicron Delta Epsilon, one of the largest academic honor societies, was established in 1963 as a result of a merger of two honor societies: Omicron Delta Gamma (founded in 1915 by Professor John R. Commons at the University of Wisconsin and Frank W. Taussig at Harvard University), and Omicron Chi Epsilon (founded in 1956 by Prof. Alan A. Brown when he was a student at the City College of New York). It became an International Honor Society in Economics in 1969. Since that time, a number of chapters throughout the world have been added.

The following are the most important objectives of Omicron Delta Epsilon: First and foremost is the recognition of scholastic attainment in economics; second is the recognition of outstanding achievements in economics on the part of economists at all levels; third is the establishment of closer ties between students and faculty in economics within their own colleges and universities; fourth is the establishment of closer ties between students and faculty in economics on all campuses; fifth is the publication of an official journal; and sixth is to emphasize the professional aspects of economics as a career field for service in the academic world, business, government, and international organizations.

Omicron Delta Epsilon is dedicated to the encouragement of excellence in economics. It encourages devotion on the part of its members as economists to the advancement of their science and to the scholarly effort to make freedom from want and deprivation a reality for all mankind.

Every Spring, juniors and seniors who become eligible, based on grades and completed coursework, receive an invitation from the Economics Department to join the ODE Honor Society and attend the ODE banquet and induction ceremony. This year's ODE ceremony will take place on April 20<sup>th</sup>. The guest speaker for the event will be Duane Bouligny '94.

# What motivated you to become an v economist?

I have always been fascinated and interested in modeling, from starting with Lego sets as a child, to building and racing elaborate RC cars (something I still do on occasion). Using large scale quantitative models to try to understand and improve the functioning of some of the more complicated aspects of our massive economy was a natural outcrop of that early fascination.

### What is your field of expertise?

Monetary policy and central banking broadly are my primary research interests. Housing markets (real estate) is a secondary research interest. I love thinking about the role human psychology plays in all of this.

# Can you briefly describe one of your research articles?

My job market paper (the one I presented when I was interviewing for the job here at PC) studied the tradeoffs individuals make

The paper enabled me to forecast the run-up of suburban real estate values following the transition to working from home during the COVID lockdown and motivated me to invest in local real estate, which ended up paying off.

### What research topics are you currently working on?

I am currently finishing an article which investigates how some of the newest tools in monetary policy can be utilized by the Federal Reserve in order to stabilize the economy in the current "ample reserves" environment.

### Which courses do you teach at PC?

Macroeconomic principles, Financial Economics, Mathematical Economics, and Money and Banking.

## **FACULTY PROFILES: DR. CHRIS LIMNIOS**

### What is your teaching philosophy?

I try to leverage the logic that economics is built on. Typically one concept in economics naturally flows out of another, and if I can draw my students' attention to how and why that logical flow occurs, they usually have an easier time understanding the larger picture. It also helps to illustrate economics concepts using relevant examples. This entails me doing my homework and trying to understand my students' perspectives a little better, something which becomes increasingly difficult as one ages.

# What do you like about teaching at PC?

We have students here who have a fantastic potential for learning if motivated in the right way. I'm all about having the "lightbulbs turn on" in my students' heads during lecture. Sometimes I'll be thinking about some research that may be proximally related to what I am lecturing on and the light bulb will all of sudden go off in my head as well!

It doesn't hurt to have (by far) the best occupation in the world... nothing else comes even close.

### Are you involved in any other studentrelated activities at PC?

I regularly involve talented students in my research. I feel it gives them a closer look at what the actual work of an academic researcher looks like. I'm also the faculty representative for the Hellenic Club on campus.

### Do you have any advice for students majoring or thinking about majoring in economics?

Read. Read. Read. Broadly. Reading philosophy also helps give economics some type of context. If we can gain a better understanding and foothold of what our purpose on this rock is, economics provides the key to implementing that purpose. Political cartoons are an especially efficient means of understanding some of the more economically turbulent times in our past.

### What do you do in your free time?

I enjoy learning Bach on the piano (currently learning the d-minor concerto), I watch movies at home with my wife, work on various projects involving our home, going out to movies followed by dinner, and occasionally I'll even play through the "Uncharted" series.

#### What is your favorite book?

I recently finished reading "Casino; Love and Honor in Las Vegas" by Nicholas Pileggi, "Phantoms in the Brain" by Ramachandran and Blakeslee, and I'm always reading "Godel, Escher, Bach" by Hofstadter.

### What is your favorite food?

Italian. Eggplant parmesan.
